



**STANDARD TERMS BETWEEN OWNERS AND FITTERS**

The Fitter agrees that he/she is personally responsible for the care, welfare, and condition of the Owner's animals during the period of the Event. The Fitter acknowledges that he/she is responsible for his/her own actions and failures to act and for the actions and failure to act of all of the Fitter's employees, agents and sub-contractors and anyone else who assists the Fitter (collectively "the Fitter's Personnel") with the fitting, care and preparation of the Owner's animals.

**The Fitter and the Owner each promises that he/she will abide by the Rules and Regulations for the Preparation and Presentation of Registered Holsteins and the Unethical Practice in the Showing, Exhibition and Promotion of Registered Holsteins, and any other Event rules and regulations (collectively "the Rules").**

The Fitter will also ensure that all of the Fitter's Personnel will comply with the Rules. The Fitter understands that a failure to adhere to the Rules could result in disciplinary measures including possible suspension or ban of the Fitter, the Fitter's Personnel, the Owner's animal(s), the Owner and/or the exhibitor of the Owner's animal(s) from the Event and future shows, exhibitions or sales and the reporting of disciplinary action, including to any association registering purebred livestock.

The Fitter and the Owner each releases and agrees to hold the Event and its organisers, officials, directors, officers, employees, representatives, agents, and volunteers (collectively "the Organisers") and the Holstein-Friesian Association of Australia Inc ("HFAA") harmless from any action taken under these terms, the Rules, or in any way connected with the Event and releases the Organisers and HFAA from and against any injury, damage, loss, liability, cost or expense suffered during or in connection with the Event, whether or not such injury, damage, loss, liability, cost or expense resulted from or was contributed to, directly or indirectly, by the acts or omissions of the Organisers and/or HFAA.

The Fitter and the Owner each agrees to indemnify and keep indemnified the Organisers and HFAA against all actions, claims, demands, losses, damage, costs (including legal costs on a full indemnity basis) and expenses for which the Organisers and/or HFAA may become liable, arising directly or indirectly from my breach of this Agreement.
