- 1) The National Board of the Holstein–Friesian Association of Australia Inc (Trading as Holstein Australia (HA)) invites nominations for one (1) Director Position on the Holstein Australia National Board. Under the organisation's Rules, the current Director, Jenny Grey, having held her current position for three (3) years must retire by rotation. Mrs Grey is eligible for re-election.

*Any nominees must be an Ordinary member of Holstein Australia and be financial to be eligible.*

- 2) The National Board of the Holstein–Friesian Association of Australia Inc (Trading as Holstein Australia (HA)) invites nominations for one (1) Breed Development and Conformation Committee (BDCC) position on the Holstein Australia BDCC. Under the organisation's Rules, the current BDCC member, Marcus Young, having held his current position for four (4) years, must retire by rotation and is eligible for re-election.

*Any nominees must be an Ordinary member of Holstein Australia and be financial to be eligible.*

- 3) The National Board of the Holstein–Friesian Association of Australia Inc (Trading as Holstein Australia (HA)) invites nominations for one (1) All Australian Selection Committee position on the Holstein Australia All Australian Selection Committee. Under the organisation's Rules, the current All Australian Selection Committee member, Robert Walmsley, having held his current position for three (3) years must retire and is ineligible for re-election due to term limits. Members can nominate for a second term after a lapse of three years.

*Any nominees must be an Ordinary member of Holstein Australia, on their respective state judges' panel and be financial to be eligible.*

*All elections of Directors and BDCC members will be held prior to the Annual General Meeting of Holstein Australia scheduled for 15 November 2018. Should there be more than one nomination for each position a ballot will be held prior.*

*The All Australian Selection Committee judges are appointed by the Board following a recommendation by the Strategic Directions Committee (SDC). No election is held.*

*Elected Directors serve for a term of three (3) years. Elected BDCC members serve for a term of three (3) years. Members appointed to the All Australian Selection Committee serve for a term of three (3) years.*

***The Nominating Member (the member who nominates someone else for a position) MUST be an Ordinary member of Holstein Australia and be financial at the time of nominating.***
